



Privacy Policy

Easy to Grow Systems, LLC (Easy to Grow Systems) currently collects personal information in one of three ways: (1) through your submission of an online form, (2) through your purchase of Easy to Grow Systems products that appear on the Website, and (3) when you place an order for Easy to Grow Systems products by phone.

Through these submissions you may be required to provide your name, address, phone number, and e-mail address. If you are placing an order for Easy to Grow Systems, you will also be required to submit your credit card and billing information. You may also choose to include your comments or questions you might have on forms.

Easy to Grow Systems also may passively collect information through the use of cookies, web beacons, and other technical means. In addition, our web servers automatically collect information about your computer and the web browser that you are using, including the Internet Protocol ("IP") address of your computer.

Easy to Grow Systems uses the personal information you submit through the Website and by phone to carry out your requests (e.g., to send you information), to process credit card transactions (if you are purchasing products), and for other purposes.
